

Dear Brothers and Sisters

Reflecting on the challenges at OC Transpo this past year, disruptions to our schedules and working conditions due to CLC 30-minute break have added strain to staffing with the increased workload. The inconsistency in the 30-minute break rule across departments is disheartening, with incidents often resulting in discipline instead of constructive conversations.

The new discipline matrix is negative because it undermines fairness and due process. When disciplinary actions are predetermined, it eliminates the opportunity for an unbiased evaluation of the circumstances surrounding an incident. This approach disregards individual contexts, hindering the ability to address issues on a case-by-case basis. Fairness and equity are essential in maintaining a healthy work environment, and predetermined discipline erodes these principles, fostering a culture of mistrust and discontent among employees.

While we've achieved victories in removing the Collision Review Committee, Fleet Safety meetings and ATO points this year. Fundamental issues persist, such as the delay in placing the ATU279 logo on uniforms for over three years, adding more time to schedules and reducing passenger abuse. The increase in grievances has really revealed a lack of commitment and compassion from the employer. The Union's commitment to fight and stand together is crucial in advocating for the rights and well-being of its members. By maintaining solidarity, the union can effectively address workplace challenges, negotiate fair conditions, and ensure that the collective voice of its members is heard. This unity is a powerful force that fosters resilience and encourages positive change within the organization. As the Union continues to stand strong, it reinforces the principle that collective action is vital to shaping a workplace that respects and values its employees.

Our relationship with OC Transpo is strained, marked by outstanding grievances and unfulfilled promises, including the awaited overdue meetings with the new Mayor for bus schedule improvements and overall morale.

In our biweekly meetings with the GM, concerns about lack of time in the runs, deadheading, and interlining routes have been voiced, yet changes seem elusive. Essential issues linger, including the need for sufficient time for recovering between runs to ensure the next trip runs on time.

DRO/ERO Operators having consent work changes, with Management not following the collective agreement, not allowing Operators to book work, and forcing them on other shifts outside their current roles has deeply affected their morale, and the newest change of them being retrained on buses shows the lack of trust in Management and having the electric train ever operate smoothly.

As we navigate these challenges, let's stay united and take pride in our daily accomplishments. This holiday season, prioritize quality time with loved ones, recognizing that coming to work or joining the workplace is not safe and has become nothing more than just a paycheck. The challenges we've faced at OC Transpo this year will most likely carry over to the next year.

Once again, please prioritize spending quality time with loved ones; remember that life extends beyond the workplace, and your health and well-being should be your top priority. I wish for everyone to embrace the fun of the season, relishing the moments with family and friends. Whether it's sharing laughter around the dinner table, creating cherished memories, or simply enjoying the warmth of companionship, these moments are invaluable.

Dear Brothers and Sisters,


I want to start by saying Merry Christmas to everyone and their families and for everyone to have a safe holiday season.

This year, we have had many ups and downs, and it felt more like a roller coaster than anything else. The Union has been trying to help everyone who has been affected by all the ups and downs. On a daily basis, we are pushing back against Management for not following the Collective Agreement and will continue to monitor and push back when the Collective Agreement has not been adhered to. I want to encourage Members to contact their Union Representatives if they feel or see that Management is breaking the Collective Agreement. The Union Representatives will then be able to help assist with the situation and determine if anything can be done and what steps are needed to help correct the issue or issues if needed. I would also like to remind Members that if you are working on buses that have come back from a vendor for repairs and there are issues with the workmanship, repair, or anything related to the vendor, please get in touch with your Union Representative so that we can look into the issue. The President (Clint Crabtree) and I have had bi-weekly morale meetings with Renée and her Senior Management team over the last two months. In those meetings, we discuss such things as money, overtime, shifts, sick leave, and morale. Those meetings will continue until morale is fixed within the Garage and OC Transpo.

This coming year, all OC Staff will see a 2% increase to their wages on April 1/2024, and all licenced staff and Apprentices, on top of the 2%, will also receive a \$1.30 wage adjustment. The Union will not stop there; we will continue to push for an Evening premium and an actual Night premium for all staff and will continue to push for better wages and shifts. I want to remind Members that if you receive a Request to Appear from your Section

Head or Supervisor, it is the Member's responsibility to contact the Union to request representation for the meeting. The union only shows up to the meeting if requested by the Member, as some Members don't take the Union into their meetings, which is their choice. This year has also been plagued with issues with our Alstom Branch; we hope to get a fair contract decision from the arbitrators' ruling sometime in December. We have successfully gained many Members and increased the Alstom Membership with the addition of the Infrastructure Group. The Union is also negotiating with the Royal Canadian Mint, and we look forward to securing a great Contract for our Mint Members.

With the year coming to an end and the holiday season around the corner, I would like to say thank you to everyone for their support, and I will continue to work hard for everyone in ATU 279. I would also like to thank my four Grievance Officers for their hard work this past year. Steve Faubert, Sri Kanagalingam, Richard Clarke, and Daniel Dorion. Thank you, everyone, and have a great holiday season. Cheers




